#### **Admission Policy**

Admissions for all Degree College programmes (Aided and Self- Financed) are conducted online.

The procedure for admission to the First Year of the Degree College is displayed on the College website. It is mandatory for students to fill in the University of Mumbai (MKCL) online admission form before filling in the College online admission form. The admission schedule will be made available from the date the H.S.C. results of the Maharashtra State Board are announced on the College website. Students should follow the admission schedule and admission notices. For admission to any class, it is necessary to produce the original and the photocopy of each of the following documents: -

- 1. Statement of marks of the previous examination.
- 2. For those who have lived in Maharashtra for 10 years and more; submit the Domicile Certificate and Income Certificate from the Tehsildar's office at the time of admission.
- 3. No Objection Certificate from the Head of the Institution last attended (for admission to the Second and Third Year only).
- 4. In case the Board/University does not issue the passing certificate, the student should obtain a letter from the concerned Board/University stating that they do not issue a Passing Certificate.
- 5. Students should pay the necessary charges for getting the marksheets verified by the Board/University from which they have passed the Std. XII examination.

For confirmation of eligibility, students should submit the following original documents before the close of the First Semester to the College Office.

- i. Statement of marks of the previous examinations (Std. XII)
- ii. Passing Certificate
- iii. Migration Certificate

#### **Attendance Norms**

#### Attendance for Learners as Per Ordinance 6086 of University of Mumbai

- 1. Every bona fide learner shall ordinarily be allowed to keep terms for the given semester in a programme of his/her enrolment only if he/she fulfils at least 75% of the attendance taken as an average of the total number of lectures, practical, tutorials, etc. wherein short and/or long excursions/field visits/study tours organised by the college and supervised by teachers as envisaged in the syllabus shall be credited to his/her attendance for the total number of periods which are otherwise delivered on the day/s. Further, it is mandatory for every learner to have minimum 50% attendance for each course and average attendance has to be 75%.
- 2. The same ratio shall be applied for computing the attendance of learners by crediting the number of periods which are missed while participating in an extracurricular /co-curricular activity/competition/camp/workshop/convention/symposium/seminar, etc., where the learner is officially representing the College /University/District/State/Country with the permission of the Principal/Director/Head of the College /Institute/ University Department or by the direction of the University Officer as the case may be wherein for the purpose of computing the average attendance the periods missed for what is envisaged here-in-above, shall be deemed to have been attended by the said learner.
- 3. The Principal/Director/Head of the concerned College/Institute/Department of the University shall be the competent authority to condone the absence of any learner further up to additional 25% if deemed fit and on recommendation of the Attendance Committee of the College/Institute/Department of the University wherein it is mandatory on the committee to do natural justice by giving a personal hearing to every learner falling short of minimum attendance for keeping terms and recommending case by case to the competent authority having verified the genuineness and gravity of the problem that justifies the learner to remain absent which generally shall be limited to his/her own sickness, sickness of parent, death of parent, etc. supported by valid evidence, documentary or otherwise.
- 4. At the end of the semester on recommendation of the Attendance Committee the Principal of the college shall display the list of the learners who are not allowed to keep terms, allowing them to appeal to the principal of the college within 3 days from the date of display of the notice. After disposing of the appeals, the principal shall intimate the same to the In-charge of Examinations to withdraw the examination forms of such defaulting learners under intimation to those learners ensuring that the communication reaches the concerned at least 10 clear days before the commencement of the respective examinations.

#### Steps taken by the College

- (i) Undertaking signed by parent as well as student at the time of admission.
- (ii) Attendance norms explained at the orientation.
- (iii) Display of monthly attendance on student notice boards.
- (iv) Periodic meeting with parents addressed by the Principal/Vice Principal.

All Principals of Affiliated Colleges, Directors of Recognized Institutions, Heads of University Departments, Autonomous Colleges/Institutions, Director of the Centre for Distance & Open Education (CDOE), and Coordinators/Directors of University Sub-Campuses (Thane, Kalyan, Ratnagiri) in the faculties of Arts, Commerce, Science, and Management are hereby informed that the implementation of the National Education Policy (NEP-2020) guidelines for Examination and Evaluation shall be applicable to Undergraduate (UG) programs for Semesters I to IV from the Academic Year 2024-25.

As per the resolution of the Academic Council held on 20th May 2025, the University of Mumbai has adopted the following Examination and Evaluation Guidelines under the National Education Policy (NEP-2020), which shall be applicable to all Undergraduate Programs in Arts, Science, and Commerce & Management (Semesters I to II) from the Academic Year 2025–2026, as detailed below.

#### I. Examination Schedule and Timetable

#### 1. Examination Dates:

The University will announce the examination slots and the overall schedule for examinations and result declaration in due course.

#### 2. Timetable Preparation:

Affiliated colleges shall be responsible for preparing detailed timetables for both Regular and KT (Keep Term) examinations, strictly within the examination slots allocated by the University.

#### II. Examination Forms – Regular and KT

- 1. All students must fill out examination forms (Regular and KT) as per the schedule issued by the University.
- 2. The processes of subject selection, form filling, and form submission shall be managed by the respective colleges.
- 3. Seat numbers will be issued in the e-smarth portal for regular and KT.

#### III. Question Paper Setting and Evaluation

#### 1. Question Paper Setting:

Colleges are responsible for setting question papers for all Regular and KT examinations conducted under their jurisdiction.

#### 2. Evaluation and Moderation:

Assessment of answer scripts, including moderation, shall be carried out at the college level.

#### 3. Interim Results:

Interim results or marks for all assessments shall be declared by the respective colleges.

#### IV. Revaluation and Marks Submission

#### 1. Revaluation / Open House:

Revaluation and/or Open House shall be conducted by colleges as per their internal academic policy and mechanisms.

#### 2. Marks Entry:

Colleges shall prepare the final mark lists and enter them in the Samarth Portal as per the University schedule.

3. All data must be thoroughly verified for accuracy before final submission. No changes will be permitted after final submission.

#### V. Result Declaration and Marksheet Generation

#### 1. Application of Ordinances & Result Declaration:

The University will apply the relevant ordinances and declare the final results for both Regular and KT examinations via the Samarth Portal.

#### 2. Marksheet Generation & DigiLocker Upload:

Digital marksheets will be generated by the University and uploaded to DigiLocker as per the University's marksheet generation policy.

#### VI. Guidelines for Defaulting Colleges

Colleges may be subjected to academic and administrative actions, including penalties, for any of the following defaults:

- 1. Failure to submit ERN (Eligibility Registration Number)
- 2. Failure to create or verify ABC ID
- 3. Incorrect subject selection
- 4. Improper or incomplete form filling
- 5. Non-generation of seat numbers
- 6. Failure to submit marks / Submission of incorrect marks

#### VII. General Compliance and Communication

All affiliated colleges are required to:

# College Rules and Regulations (for more details refer to the Code of Conduct document on the college website)

- 1. Students are expected to conduct themselves in a manner worthy of an educated Indian citizen. Such conduct is based on respect for the dignity and right of individuals, respect for public and personal property, and personal and academic honesty & integrity. Students are responsible to the principal for their conduct in college.
- 2. At the time of admission, every student shall sign a declaration on her/his admission form, that s/he will abide by all the rules and regulations and accept the decision of the principal in all matters as final. S/he will also give an undertaking to accept the Maharashtra State Higher Secondary Education Board's Regulation, 1997, No. 88(1)(a), (i) and (ii) in the Junior College, and University Ordinances 0.6086 for Senior College, which inter alia provides for the withdrawal of the Board / University examination form.
- 3. It is the responsibility of the student to read the notice boards and check the college website regularly for important announcements made by the College authorities from time to time. Failure to do so will not be considered a valid excuse for the ignorance of notices and announcements.
- 4. No student should be found loitering in the corridors or in the lobby during lecture hours.
- 5. Students are required to wear their identity cards while they are on campus. Identity cards must be shown if demanded by the Principal/Lecturer or any other teaching /non-teaching member of the staff.
- 6. Students are advised against sitting on the parapet walls and on desks with their feet on the benches.
- 7. Students are expected to take proper care of college property. Damaging college property e.g. disfiguring walls, doors, windows, or breaking furniture, misuse of A.C., LCDs, Speakers, Computers/Laptops, etc., will be considered as a breach of discipline.
- 8. Students should keep the college campus clean, segregate waste, and conserve electricity and water.
- 9. Any form of smoking, playing cards, any form of gambling, consumption of alcohol and the use, possession and/or distribution of drugs are strictly prohibited in the college premises.
- 10. Students found accessing/downloading objectionable content from the internet shall be liable for disciplinary action.
- 11. Insubordination and unbecoming language or misconduct in any form will result in immediate and strict disciplinary action.
- 12. Students are advised to refrain from bringing or wearing any item, ornament, bangle, kada or finger rings on campus. This measure has been taken to ensure the safety and well-being of all members of the college community. Non-compliance of this directive will result in the concerned item being confiscated by the security personnel.
- 13. Smartphones used in the certain areas of the college building will be confiscated. The use of it or any other electronic communication gadgets or musical gadgets is strictly prohibited during lecture hours.

- 14. Any kind of demonstration or protest that restricts the freedom of the college community and disrupts the smooth running of the college is banned.
- 15. All students must follow the college dress code which is displayed on the notice boards.
- 16. Students conduct within the college, outside the college, or online, should not in any way interfere with orderly administration and discipline.
- 17. No society or association shall be formed in the college and no person invited to address a meeting without the principal's prior permission.
- 18. No student shall collect any money as contribution for educational visits, get-togethers, study notes, charity, or any activity without the prior sanction of the principal.
- 19. The college does not organise picnics and tours except educational tours in which case parents will be duly informed.
- 20. In college debates and other meetings, the Chairperson shall be an individual approved by the principal and the subject of debates shall have the previous approval of the principal.
- 21. No students shall communicate any information to or write about matters dealing with the college administration to the Press.
- 22. Students should not leave their books, valuables, and other belongings in the common rooms/classrooms. They are advised to carry their possessions with them whenever they leave the common rooms/classrooms. The college is not responsible for lost property. Students should deposit property found by them in the college office. Owners of lost property should check with the college office and provide adequate proof of ownership to claim the lost property.
- 23. Subject to the availability of space, a parking facility is provided for students' two-wheelers. Parking of cars, for students, is not allowed. The college is not responsible for any damage to or theft of vehicles. No one can claim parking as a matter of right. The time for entry into and exit from the campus will be notified by the principal. Students who do not follow the instructions of the security staff will forfeit their parking facility.
- 24. A student found guilty of ragging and sexual harassment will be expelled.
- 25. Students are not permitted to invite outsiders to the college campus; failure to comply will result in strict disciplinary action.
- 26. If, for any reason, the continuance of a student in college is in the opinion of the principal detrimental to the best interests of the college, the principal may ask such a student to leave college without giving reasons for the decision. The principal's decision shall be final and binding on the student.
- 27. Additional rules as deemed necessary will be displayed on the notice board and college website from time to time. Matters not covered by the existing rules shall rest on the absolute discretion of the principal.
- 28. The principal may expel/suspend any student for violating the rules or for any other discipline related issues. The principal's decision will be final.
