WHEREAS the UNESCO Cardinal Paul Poupard Foundation Chair of Inter-Religious and Inter-Cultural Dialogue at St Andrew's College, (of the First Part), established in 2015, is desirous of commencing a Post Graduate Diploma Course in Inter Religious Collaboration for Sustainable Development for a Humane Society, in fulfilment of the objectives of the Chair...

WHEREAS the party of the first part is desirous of being the lead college that will run the Post Graduate Diploma Course in Inter Religious Collaboration for Sustainable Development for a Humane Society, and has approached the Institute of Indian Culture, Andheri, and Nirmala Niketan College of Social Work to collaborate in the running of the course and of postgraduate research programmes ...

WHEREAS the Institute of Indian Culture, a Post Graduate Research Centre in Anthropology and Sociology, located in Mahakali Road, Andheri East, Mumbai 400 093, (of the Second Part), affiliated to the University of Mumbai, is desirous of collaborating with the party of the first part in the running of the Post Graduate Diploma Course in Inter Religious Collaboration for Sustainable Development for a Humane Society, in fulfilment of the objectives of the Institute of Indian Culture...

WHEREAS the Nirmala Niketan College of Social Work, a Post Graduate Research and Teaching Centre, (of the Third Part), affiliated to the University of Mumbai, is also desirous of collaborating with the party of the first part in the conducting of the Post Graduate Diploma Course in Inter Religious and Inter Cultural Dialogue for Sustainable Development for a Humane Society, in fulfilment of its objectives...

This Memorandum of Understanding has been agreed upon by the Superiors of the three Institutions who are affixing their signatures here below, in order to foster their collaboration in the running of the Post Graduate Diploma Course in Inter Religious Collaboration for Sustainable Development for a Humane Society, as per the following agreement:

- 1. The objectives of the Post Graduate Diploma Course in Inter Religious Collaboration for Sustainable Development for a Humane Society are:
 - a) To promote an integrated system of research, training, information documentation and animation of inter-religious and intercultural dialogue.
 - b) Facilitating collaboration between high level researchers and teaching staff in other similar institutions in India and other regions of the world.
 - c) To facilitate the conduct of advanced research on religious, anthropological, cultural, social and economic issues.
- The duration of the course will be one academic year, comprising 18 credits of 180 hours, including lectures, discussions, project work, workable at the rate of two hours a day of lecture time.
- 3. The Course will be run at the Nirmala Niketan College of Social Work, Churchgate, Mumbai for the sake of convenience of its accessibility to resource persons and participants.
- 4. The cost of running of the Course will be borne solely by the UNESCO Cardinal Paul Poupard Chair of Inter-Religious and Inter-Cultural Dialogue at St Andrew's College, the party of the first Part; the Executive President of the UNESCO Cardinal Paul Poupard Foundation Chair of Inter-Religious and Inter-Cultural Dialogue at St Andrew's College, the Chair Holder, has agreed to guarantee the financial liabilities.

- 5. The party of the third part, Nirmala Niketan College of Social Work, Chandagate, agrees to provide one room for the purpose of conducting the course, and other basic administrative facilities, for which the party of the first part will make a reimbursement.
- 6. The Rector of the Party of the first part will be the Administrative Coordinator of the Post Graduate Diploma Course in Inter Religious Collaboration for Sustainable Development for a Humane Society, responsible for the smooth conduct of the course in keeping with its objectives.
- 7. The Party of the first Part represented by the Rector, the Party of the second pant represented by the Superior, and the party of the third part represented by the Superior, will jointly appoint the Academic Coordinator of the Post Graduate Diploma Course in Inter Religious Collaboration for Sustainable Development for a Humane Society with the requisite qualifications and experience, fully responsible for the conduct of the Course and payment of all outgoings. The Academic Coordinator will regularly report to the Executive Presidentand Chair Holder of the UNESCO chair.
- 8. The Party of the first Part represented by the Principal, the Party of the second part represented by the Director, and the party of the third part represented by the Principal, will jointly be responsible for smoothly running of the academic course by formulating the syllabus, recruiting of professors and research undertakings of the said Post Graduate Diploma Course in Inter Religious Collaboration for Sustainable Development for a Humane Society.
- 9. Keeping in mind the foundational aims and objectives of this Course, the subjects selected for this course as well as the Professors, may be chosen as per the changing situations in society and the corresponding needs.
- 10. Competent professors will be selected by the Academic Coordinator, and their remuneration will be as per University of Mumbai rules and regulations.
- 11. Studentsregistering for this Postgraduate Diploma Course will have to pay the party of the first part a nominal fee fixed by the Administrative Coordinator of the course.



- 12. The Academic Coordinator of the Course will report to the Principals of the three parties and to the ExecutivePresidentand Chair Holder of the UNESCO Cardinal Paul Poupard Foundation Chair of Inter-Religious and Inter-Cultural Dialogue at St Andrew's College.
- 13. In case of any disagreement or dispute, the Chairman of the St Andrew's Educational Foundation, the Archbishop of Bombay, will have the final say.

This Memorandum of Understanding is entered into on 3rd Oct 2017 at St Andrew's College, Mumbai.
