Report of Accountancy Association 2017-18

1. ICAI & GST Day:

On 1st July, 2017, ICAI FOUNDATION DAY & GST DAY was celebrated: Students prepared charts encouraging students to join Chartered Accountancy course. GST AWARENESS DRIVE was conducted by asking students to submit articles on GST reflecting their opinion. Lectures were taken for SYBCOM & TYBCOM students to reflect the changes in Indirect Taxation and its impact on various stakeholders. 159 students of BCOM attended the session

2. Guest Lectures:

- On 10th July, 2017, CA Deep Desai, Partner, M/s SLM & Co. spoke to 69 BCom students on GST. The talk included Accounting aspects, impact of GST on Wholesalers, Retailers and Consumers. The session gave a practical approach towards Billing after GST, returns to be filed and problems faced by Manufacturers to adopt GST.
- On 10th October, 2017 Dr. Nirmala Joshi of MET Institute spoke to 52 TYBCOM students on 'Career opportunities in Finance'. The talk covered Career prospects in the field of Accountancy, Finance, Banking and Insurance outside India, Courses available, Examination schedule, and Job opportunities.
- On December 18, 2017, Dhruvi Dharia, Co- founder, Intern theory spoke to 152 BCom students on 'Careers in Stock markets' and 'ONLINE STOCK MARKET'. He conducted a Mock Stock session reflecting importance of Stock Markets courses and its job prospects.
