Staff Advancement Committee

The Staff Advancement Committee is dedicated to empowering the faculty in a variety of ways, from enabling enhancement of pedagogic and research skills to enhancing personal wellness. Amongst the activities the committee organises is the annual Faculty Development Programme. Hosted over four days, from 15-18 June 2021, the FDP included sessions conducted by the BSE Forum. The sessions on 'Investing in Challenging Times' and 'Asset Allocation for Wealth Creation' (16-17 June 2021) conducted by Dr. Aditya Srinivas, (Capital market and financial markets professional with specialization in Macro Economics and Fundamental Research), created awareness about investment options available to salaried employees and ways to optimize financial resources. Since the online examination pattern required the staff to work with Excel to prepare multiple choice-based question papers, the FDP included two sessions on Excel by Ms. Mayuri Dhamecha, an experienced trainer from Raj Computers Academy. The sessions introduced the staff to numerous operations of Excel such as Advance Formatting options, Conditional Formatting, Advance Sort & Filter, Logical Functions, and Pivot Table amongst others.
