

ACTIVITIES OF DEPARTMENT OF ACCOUNTANCY - 2023-2024

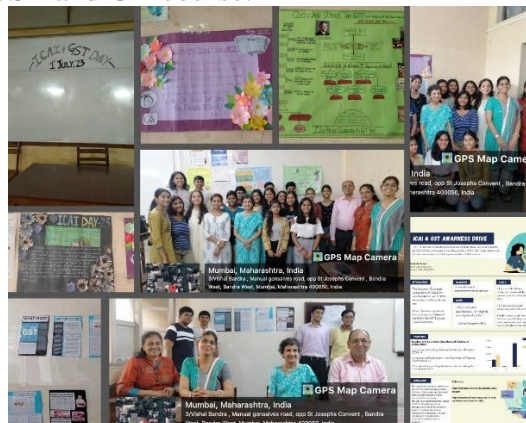
1. SKILL DEVELOPMENT COURSES / TRAINING PROGRAMS

A 30 hours certificate course on Goods & Service Tax was organized from 18 April 2023 to 24 June 2023. The 30 hours course was divided into 15 sessions of 2 hours each excluding the online exam session of 2 hours. The 12 theory sessions of 2 hours each were delivered online on Zoom platform and the practical sessions were conducted offline in the college's computer lab. An additional 2 hours online exam was also conducted for all the participants on the Zoom platform. The course conducted by Edutech Centre by faculties CA Rupal Haria & CA Dipti Mody provided training related to registration, time-value-place of supply, input tax credit and return filing of GST. 16 students undertook the training. The students were given certificates at the end of the programme.



2. ICAI FOUNDATION DAY AND GST DAY

On 1st and 2nd July 2023, ICAI Foundation Day & GST Day was celebrated. On the occasion, 18 SY and TY BCom students participated and submitted charts and articles to enhance awareness on GST and CA course.



3. ANDREAN ACCOUNTANCY BULLETIN BOARD

In June 2023, articles were invited from B.Com students from Newspapers/ Magazines related to Accountancy/ Finance and Taxation along with comments of students to be displayed on the Accountancy Notice board. 42 BCOM Students participated for the same.



4. VISIT TO MET INSTITUTE

On January 19, 2024, 30 students of TYBCOM visited the MET institute. The visit covered series of Mock Personal Interviews (PI), Group Discussions (GD), and Aptitude Tests conducted by MET Asian Management Development Centre. These activities were strategically designed to provide students with a simulated experience akin to real-world academic assessments, offering them a valuable opportunity to refine their skills and enhance their readiness for future applications. The exposure to a simulated academic environment equipped them with the confidence and acumen necessary to navigate future assessments and admissions processes for higher education.



5. INVESTOR AWARENESS PROGRAMME

On 1st February 2024 an Investor Awareness Programme was organised from 10:30 a.m. to 12 p.m. in the AV Room. The programme in which 78 students attended was conducted to help them understand the basic concept of investment, stock market, mutual funds, smart investor and to learn how to build long term investment.

The speaker Ms. Soniya Mashelkar, an alumni of our college and a certified NISM trainer (National Institute of Securities Markets) gave a brief introduction to the Stock Market, making students aware of the rules and regulations of trading in the market. She then elaborated on the precautions to be taken before buying stocks, educating young investors about the financial markets, investment opportunities and risks. The students were actively engaged throughout the program through Q&A session. The session concluded with a vote of thanks given by Ms. Riya Singh.



6. ANALYSIS OF INTERIM BUDGET 2024

On 15th of February, 2024 students participated in a competition wherein they had to make a presentation on the topic 'Analysis of Interim Budget 2024'. The competition guided students to understand the Interim Budget 2024 and its implications.
